1. **Approval of Minutes of January 9, 2018:** Tray Harkins motioned to approve the minutes of the January 9, 2018 meeting. Nate Williams seconded. Kim McElwee abstained. Motion approved.

 2. **Discussion: Updates on Community Center & Events:** Brittanie Propes, Facility Supervisor showed a video of Jesse Hall with a member and trainer explaining how they use the facility and the progress they have seen.
