COUNT. I

**Charge Code: 566.030-002Y20201198.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 566 030, RSMo, committed the **Felony of Rape in the First Degree**, punishable upon conviction under Section 566 030, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly had sexual intercourse with T J. by the use of forcible compulsion.

The range of punishment for the unclassified felony of first degree rape is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than five years

COUNT II

**Charge Code: 566.060-002Y20201199.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 566 060, RSMo, committed the **Felony of Sodomy in the First Degree**, punishable upon conviction under Section 566 060, RSMo, and subject to lifetime supervision under Section 217 735, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly had deviate sexual intercourse with T J , by the use of forcible compulsion by touching T. J.'s anus with his penis

The range of punishment for the unclassified felony of first degree sodomy is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than five years

COUNT. III

**Charge Code: 566.060-002Y20201199.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 566 060, RSMo, committed the **Felony of Sodomy in the First Degree**, punishable upon conviction under Section 566 060, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly had deviate sexual intercourse with T J., by the use of forcible compulsion by touching T. J.'s mouth with his penis

The range of punishment for the unclassified felony of first degree sodomy is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than five years

COUNT. IV

**Charge Code: 566.060-002Y20201199.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 566 060, RSMo, committed the **Felony of Sodomy in the First Degree**, punishable upon conviction under Section 566.060, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly had deviate sexual intercourse with T J , by the use of forcible compulsion by penetrating T J's anus with an object done for the purpose of terrorizing T J

The range of punishment for the unclassified felony of first degree sodomy is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than five years.

COUNT. V

**Charge Code: 566.060-002Y20201199.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 566.060, RSMo, committed the **Felony of Sodomy in the First Degree**, punishable upon conviction under Section 566 060, RSMo, and subject to lifetime supervision under Section 217.735, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly had deviate sexual intercourse with TJ , by the use of forcible compulsion by penetrating T. J's vagina with a device equipped with electrical current done for the purpose of terrorizing T J..

The range of punishment for the unclassified felony of first degree sodomy is imprisonment in the custody of the Missouri Department of Corrections for life or for a term of years not less than five years

COUNT: VI

**Charge Code: 565.110-002Y20201099.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 565.110, RSMo, committed the **Class B Felony of Kidnapping in the First Degree**, punishable upon conviction under Section 558.011, RSMo, in that between September 1, 2022 and October 7, 2022, defendant confined T. J. for a substantial period, without T. J.'s consent, for the purpose of facilitating the commission of a felony

The range of punishment for a class B felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than five (5) years and not to exceed fifteen (15) years

COUNT: VII

**Charge Code: 565.052-001Y20201399.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 565.052, RSMo, committed the **Class D Felony of Assault in the Second Degree**, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly caused physical injury to T. J. by means of a dangerous instrument by striking T. J. with an object.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years, or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution, or by a fine not to exceed ten thousand dollars (\$10,000), or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

COUNT: VIII

**Charge Code: 565.052-001Y20201399.0**

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 565.052, RSMo, committed the **Class D Felony of Assault in the Second Degree**, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly caused physical injury to T. J. by means of a dangerous instrument by shocking and/or burning her torso

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by

both imprisonment and a fine If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime

COUNT IX


Charge Code: 568.045-005Y20203899.0

The Grand Jurors of the County of Clay, State of Missouri, charge that the defendant, in violation of Section 568 045, RSMo, committed the **Class D Felony of Endangering the Welfare of a Child in the First Degree**, punishable upon conviction under Sections 558 011 and 558 002, RSMo, in that between September 1, 2022 and October 7, 2022, in the County of Clay, State of Missouri, the defendant knowingly acted in a manner that created a substantial risk to the life, body and health of L. H. (DOB 06/02/2014), a child less than seventeen years old, by leaving unsecured firearms in areas accesible to the child.

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years, or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution, or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime



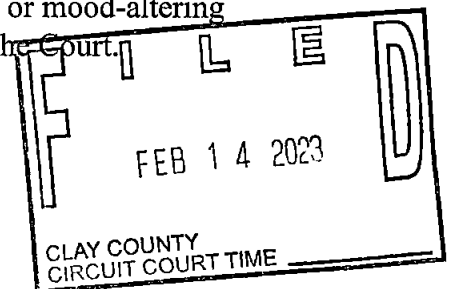

**NONMONETARY TERMS AND CONDITIONS OF BOND**

Following Indictment, in accordance with Missouri Supreme Court Rules 22 04 and 33 01, the Court hereby Orders (in addition to the monetary bond amount, if any, set forth on the Indictment itself) nonmonetary bond conditions as set forth below

- Defendant's bond shall be supervised by NDS. Defendant shall meet with his/her Bond Supervision Officer in person at least twice per week
- Defendant shall be placed on electronic monitoring and house arrest
  - Prior to release on bond.

  - Defendant shall not leave his/her residence except for
    - Court Appearances
    - Work/School.

- Defendant shall submit to random urinalysis, minimum 2 per week
- Defendant shall not possess or consume any amount of alcohol whatsoever, not enter any location where alcoholic beverages are the primary product for sale
- Defendant shall not possess or consume any product or substance containing any amount of THC, whether by prescription or not, without express permission of the Court, nor shall Defendant enter the premises of any location where such products or substances are the primary item for sale.
- Defendant shall not possess or consume any amount of any mind or mood-altering prescription controlled substance without express permission of the Court.
- Defendant shall not possess any firearms or ammunition





- Defendant shall be placed on \_\_\_\_\_ electronic alcohol monitoring
